The project, which conveys a larger percentage of the City's downtown area sewer flows, lies within the Resource Management Area of the Chesapeake Bay Preservation Area. The replacement of the compromised sanitary sewer main will reduce the probability of impacts to water quality by reducing potential for sanitary sewer overflows. Any discharge from the aging sewer is a violation of the Clean Water Act.

The project will replace a 15-inch vitrified clay sewer main that has several alignment and material defects impacting the pipeline capacity. Sanitary sewer discharges have occurred previously during storm events having potential impacts to the water quality within the abutting stream. The stream flows to the Nansemond River which is a tributary of the Chesapeake Bay. Replacement of the sewer main will provide the sufficient capacity to minimize any potential for release of wastewater to the stream and ultimately the Chesapeake Bay watershed. The Chesapeake Bay and its tributaries are home to many aquatic species, which are harvested for consumption. Protection of the water quality benefits all communities who depend on the Bay's improved water quality.
