**A BILL**

To direct the Secretary of Education to award grants to local educational agencies to establish or improve world language or dual language programs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “World Language Edu-  
5 cation Assistance Program Act” or the “World LEAP  
6 Act”.

1 **SEC. 2. PURPOSE.**

2 The purpose of this Act is to establish and make as-  
3 sistance available to the World Language Education As-  
4 sistance Program in order to—

5 (1) establish or improve and carry out World  
6 Language Education Assistance Program grant pro-  
7 grams;

8 (2) support and uplift dual language and world  
9 language programs; and

10 (3) provide students with the language skills  
11 necessary for an interconnected and global world.

12 **SEC. 3. FINDINGS.**

13 Congress finds the following:

14 (1) Recent academic studies demonstrate that  
15 America's language capacity has reached a crisis  
16 point, with only one fifth of United States residents  
17 speaking a language other than English at home, 90  
18 percent of United States-based employers reporting  
19 a reliance on employees with language skills other  
20 than English, and one third of foreign language-de-  
21 pendent employers reporting a language skills gap.  
22 This language crisis has real world implications for  
23 business, government, the military, and diplomatic  
24 and intelligence services.

1           (2) The Department of Education does not  
2           have an innovative world languages program for ele-  
3           mentary and secondary students.

4           (3) The Nation’s education system is suffering  
5           from severe shortages of world language, English  
6           learner, and bilingual and dual language immersion  
7           educators.

8           (4) The lack of a Federal elementary and sec-  
9           ondary school world language and dual language  
10          program, coupled with the continuing shortage of  
11          world language and bilingual teachers, creates sig-  
12          nificant obstacles to providing equitable opportuni-  
13          ties for all students to develop multilingualism.  
14          English learners, a population which has grown by  
15          2,100,000 between 2000 and 2019, have been dis-  
16          proportionately impacted.

17          (5) The Federal Government has a strong in-  
18          terest in better preparing American students to com-  
19          pete in the global economy.

20 **SEC. 4. DEFINITIONS.**

21          In this Act:

22           (1) **COMMUNITY-BASED HERITAGE LANGUAGE**  
23          **SCHOOL.**—The term “community-based heritage lan-  
24          guage school” means a nonprofit, community-based  
25          school that offers classes for students in pre-kinder-

1 garten through grade 12, for the purpose of main-  
2 taining and teaching the language and culture of  
3 non-English speaking communities.

4 (2) DUAL LANGUAGE PROGRAM.—The term  
5 “dual language program” means—

6 (A) with respect to pre-kindergarten and  
7 elementary school, a bilingual education pro-  
8 gram in which students receive instruction in  
9 English and a language other than English for  
10 at least half of the instructional school day for  
11 each year of pre-kindergarten and elementary  
12 school, with the goal of achieving proficiency in  
13 both languages; and

14 (B) with respect to grades 6 through 8, a  
15 bilingual education program in which students  
16 who participated in a program described in sub-  
17 paragraph (A) continue to receive instruction in  
18 English and a language other than English for  
19 at least half of the instructional school day for  
20 each year of such grades 6 through 8.

21 (3) ESEA DEFINITIONS.—The terms “English  
22 learner”, “secondary school”, “local educational  
23 agency”, “professional development”, “Secretary”,  
24 and “State” have the meanings given those terms in

1 section 8101 of the Elementary and Secondary Act  
2 of 1965 (20 U.S.C. 7801).

3 (4) HERITAGE LEARNER.—The term “heritage  
4 learner” means an individual—

5 (A) with proficiency in, or a cultural con-  
6 nection to (through family, community, or coun-  
7 try of origin), a language other than English;  
8 and

9 (B) who is studying such language in pre-  
10 kindergarten, elementary school, or secondary  
11 school.

12 (5) WORLD LANGUAGE PROGRAM.—The term  
13 “world language program” means a program that  
14 educates and prepares pre-kindergarten, elementary,  
15 or secondary school students to communicate, in a  
16 proficient and culturally competent manner, with in-  
17 dividuals who speak a language other than English.

18 **SEC. 5. WORLD LANGUAGE EDUCATION ASSISTANCE PRO-**  
19 **GRAM.**

20 (a) ESTABLISHMENT.—

21 (1) IN GENERAL.—The Secretary shall award,  
22 on a competitive basis, grants to local educational  
23 agencies to establish and carry out new, or improve  
24 existing world language or dual language programs.

1           (2) DURATION.—A grant awarded under this  
2           section shall be for a period of 3 years and may be  
3           renewed at the discretion of the Secretary.

4           (b) APPLICATION.—A local educational agency desir-  
5           ing a grant under this section shall submit to the Sec-  
6           retary an application at such time, in such manner, and  
7           containing such information and assurances as the Sec-  
8           retary may require.

9           (c) CRITERIA FOR SELECTION.—

10           (1) IN GENERAL.—In awarding a grant to a  
11           local educational agency under this section, the Sec-  
12           retary shall select applications describing programs  
13           that—

14                   (A) provide approaches to instruction that  
15                   lead to demonstrated growth in language pro-  
16                   ficiency from kindergarten through grade 12;

17                   (B) can be disseminated and duplicated in  
18                   other local educational agencies;

19                   (C) have a plan for how the program will  
20                   continue after the conclusion of the grant pe-  
21                   riod; and

22                   (D) include a professional development  
23                   component.

1           (2) PRIORITY.—In awarding grants under this  
2 section, the Secretary shall give priority to applica-  
3 tions describing programs that—

4           (A) include intensive summer professional  
5 development for world language program and  
6 dual language program teachers;

7           (B) enter into partnerships with commu-  
8 nity-based heritage language schools and com-  
9 munities;

10          (C) provide world language and dual lan-  
11 guage immersion programs, including with re-  
12 spect to English learners and heritage learners;

13          (D) are carried out through a consortium  
14 that shall include the agency receiving the grant  
15 and an elementary school or secondary school  
16 served by such agency, with a preference for  
17 consortia that include an institution of higher  
18 education;

19          (E) collaborate with the appropriate State  
20 licensure office to broaden pathways for lan-  
21 guage or dual language teacher certification; or

22          (F) conduct outreach and recruit sec-  
23 ondary and post-secondary students, including  
24 former English learners and heritage learners,  
25 into programs that prepare such students to be-

1           come dual language or world language program  
2           teachers.

3           (d) USE OF FUNDS.—A local educational agency that  
4 receives a grant under this section shall—

5           (1) reserve not less than 20 percent of such  
6 grant funds to provide—

7           (A) accessible pathways for paraprofes-  
8 sionals to gain certification and licensure as  
9 world language or dual language teachers; and

10           (B) professional development for certified  
11 and licensed world language or dual language  
12 teachers; and

13           (2) reserve not more than 5 percent of such  
14 grant funds to evaluate the efficacy of programs car-  
15 ried out with funds awarded under this section; and

16           (3) after making the reservations required  
17 under paragraphs (1) and (2), use the remainder of  
18 such grant funds to establish and carry out new,  
19 and improve existing, world language or dual lan-  
20 guage programs (including any associated adminis-  
21 trative expenses).

22           (e) REPORTING REQUIREMENTS.—

23           (1) IN GENERAL.—Not later than 18 months  
24 after receiving a grant under this section, each local

1 educational agency shall submit to the Secretary a  
2 report that—

3 (A) describes the implementation of the  
4 program for which the local educational agency  
5 received the grant; and

6 (B) includes data that identifies—

7 (i) the number of students enrolled in  
8 language education at the elementary and  
9 secondary schools served by the local edu-  
10 cational agency prior to receiving a grant  
11 under this section;

12 (ii) the number of students enrolled in  
13 such language instruction as of the date of  
14 submission of the report;

15 (iii) the number of certified bilingual  
16 educators working for the local educational  
17 agency prior to receiving a grant under  
18 this section;

19 (iv) the number of certified bilingual  
20 educators working for the local educational  
21 agency as of the date of submission of the  
22 report; and

23 (v) levels of community support for  
24 language education—

1 (I) prior to receiving a grant  
2 under this section; and

3 (II) as of the date of submission  
4 of the report.

5 (2) STUDENT PRIVACY.—A local educational  
6 agency shall prepare the report required under para-  
7 graph (1) in a manner that protects the privacy  
8 rights of each student in accordance with section  
9 444 of the General Education Provisions Act (20  
10 U.S.C. 1232g; commonly known as the “Family  
11 Educational Rights and Privacy Act of 1974”).

12 (f) AUTHORIZATION OF APPROPRIATIONS.—There  
13 are authorized to be appropriated to carry out this section  
14 \$15,000,000 for fiscal year 2026 and for each subsequent  
15 fiscal year.
